3. Retailer's Obligations for Huggalugs-Smitten-NOO Products. Retailer accepts the appointment as stated above and agrees that they will not take any action to diminish the value or reputation of Huggalugs-Smitten-NOO products. Retailer further agrees:

- a. To stock an inventory of Huggalugs-Smitten-NOO products sufficient to satisfy the normal demand for Huggalugs-Smitten-NOO products.
- b. To sell Huggalugs-Smitten-NOO products only (i) at Retailer's Location and (ii) through Retailer's website and only on terms and policies consistent with instore sales. **Selling on auction sites such as Ebay or coops is prohibited.**
- c. Not to take any action that diminishes or may diminish the value or reputation of Huggalugs-Smitten-NOO products
- d. Not to cosign, sell, or transship Huggalugs products to any person or entity for resale, transshipment, or other distribution.
